#### President's Corner

As the 2023-2024 season winds down, I can confidently reflect that it has been a very good one. The seasons that we dealt with the pandemic are now in the rear-view mirror. We always have some issues that we have to deal with (bears, landscaping, irrigation, front gate, etc.) but overall, this season has been a very positive one. Once again, the Activities Team produced and directed a number of successful events (picnics, chili fiesta, bake sale, etc.). The Bocce Committee had a very successful season with many new players joining in the competition and a new championship team (Hawks). The Pool 3 Cabana was constantly booked with a variety of events and activities as well as private parties for a number of different occasion and celebrations. For a community without a clubhouse, we have a tremendous number of activities taking place on a weekly basis.

The Master Board has one meeting remaining on Wednesday, April 17<sup>th</sup> at Pool 3 at 10:00 before we break for the summer. The Master Board's Annual Meeting was held on Wednesday evening, March 20<sup>th</sup> with a large crowd of about 85 owners present. Charlie Ferrara (Tourmaline) was announced as the new president of his association, and Alex DeSanctis was welcomed as the new president of the Turquoise Association. The current Executive Board of Officers was reelected for another year, including myself for my 16<sup>th</sup> year as President.

A number of accomplishments of the past year were highlighted by Property Manager Suzanne Foster, who was recognized enthusiastically by the audience on her 2<sup>nd</sup> anniversary in her position, such as: the many projects completed by our Maintenance Man Roberto Garriga, the signing of a 7-year Comcast renewal contract that will save us about \$29,000 in the current 2024 budget and we will also receive a \$118,000 signing bonus. Suzanne also mentioned the positive reactions to the newly resurfaced tennis/pickleball courts, as well as the recent trimming of the Saw Palmettos on Gabriel Cir. and Belina Dr. as well as behind 164 Belina alongside Lake 1. I advised the residents that there is still a bear presence around the community and we have to be constantly vigilant and aware of them, especially after dark. We haven't had a case yet of a bear being aggressive with anyone or any of your pets, but the key seems to be about disposing of your food waste and putting out barrels and/or putting trash bags in the dumpsters.

On March 26<sup>th</sup> some representatives from Comcast made a presentation to about 75 residents at the Pool 3 Cabana that was very informative about the use of our X1 system and they also answered many questions about the use of the Xfinity apps on your iPhone or android phones. They also provided a number of tips for our residents which I have listed on page of this newsletter.

Many of you will be leaving soon for the summer and we wish you safe travels and hope to see you back here for the 2024-2025 season! As always, I will keep everyone updated via e-mail about any issues of concern.

#### Treasurer's Report

2023 is now history and as reported at the annual meeting, we did not have a good year budget wise. This was due to irrigation repairs being \$30,000 over budget and adjustments in the way Resort pays our yearly bills. We are still in good financial shape. We finished the year with \$106,000 in operating Equity, \$354,600 in reserves.

2024 looks much brighter. With the signing of the new Comcast contract, we will start the New Year with a surplus of over \$43,000. \$30,000 is coming from a 6% reduction in cable and internet fees plus an additional \$13,000 per year in income as part of the signing bonus over the next 9 years. That being said, we are trending to be over budget in a few area for 2024. Those areas are oak tree trimming \$9,000, water usage \$2,000, but that still leaves us a surplus of \$32,000 for the year.

As far as reserves we are starting the New Year with \$354,600 in reserves. We only plan to spend around \$38,000 in 2024 while adding \$102,000 in Contribution plus \$10,000 in interest so we are trending to end 2024 with \$428,000 in reserves. Currently we have CD'S paying as high as 5.5% in interest and Money Market accounts paying 4%. Sue and I will be leaving at the beginning of May. Hope everyone has a great summer. God willing we will see you all in the fall. Thanks, Mike Mears

# COMCAST TIPS

Sapphire Lakes has a "bulk services" contract with Comcast whereby all 590 units receive Internet and Video services that are paid through the maintenance fees. We have fiber optics that were installed 8 years ago and the Comcast X1 system that provides each unit with up to three boxes that have access to 140+ channels and the ability to record up to 150 hours of programming. The remote also has "voice activation" which makes it easy to find channels and/or specific programs or events. The following are some tips that you might find helpful.

For residents who would like the **large button remote** for their X1 boxes, they can call 1-855-270-0379. One will be mailed to you.

#### Pool Telephones

The landline telephones have been removed from all four pools and replaced with 911 Emergency Cell Phones.

#### Rental of Cabanas

Any resident wishing to use any of the cabanas for personal gatherings must apply fourteen (14) days in advance. Applications can be obtained from Suzanne Foster, Property Manager. This applies only to cabanas. Pools and pool decks are always open to all residents and may not be reserved or rented. A deposit of \$50 is required which will be refunded if the area is cleaned up property. **Social distancing and hygiene plans will be reviewed with applicant before approval.** Further details are available in the application.

#### Attention Walkers, Bikers and Drivers

**Walkers**: please make sure that you walk AGAINST the traffic when walking the streets at Sapphire Lakes and wear light colors and/or reflective clothing when walking in non-daylight hours. **Bikers**: please make sure to ride WITH the traffic and to have reflectors and/or lights on your bicycle. Helmets are recommended. We want everyone to be safe!!

And vehicles, please obey the Stop signs including those at the driveways. Please be aware of those on the street walking or biking in these areas. We have been fortunate that no one has caused an accident yet but the potential is there. Please do this for the safety of all!

#### Entrance Gates

Unit owners may purchase additional gate access cards and vehicle bar codes at a **cost of \$25.00** by check or money order only and are available from our Property Manager, Suzanne Foster. Credit cards are now accepted but there is a \$1.06 service charge. NO CASH.

#### Pool Umbrellas

All pools have umbrellas on the decks. If you are the last to leave the pool area, please be responsible and lower any umbrellas that are open. Thank you.

#### **Defibrillators**

An Automated Electronic Defibrillator (AED) is installed at the cabana at the Recreation area restroom and all four pools. Before using the AED machine, assure that **911** has been called. Turn on the AED and follow the audio prompts.

#### Central Car Washing Area

There is an area located near the recreation area washroom facility for residents to wash cars. It is **mandatory** for boats to be washed only in this area. Boat rinsing should be limited to 15 minutes after it has been in saltwater.

#### **Comcast Issues**

Any Comcast related issues should be addressed with Comcast by calling 1-800-XFINITY stating you are part of the Bulk Services Contract at Sapphire Lakes. It is also important to note that every Sapphire Lakes unit has a Comcast account. If you sell your unit, please be sure your name is removed from the account to ensure that you are not billed in the future. It would also be prudent to turn in your equipment to Comcast allowing the new owner to set up their own account with Comcast.

#### Your Pets

Please report any violations of the pet rules that you witness or observe to our Property Manager, Suzanne Foster (353-2465) so that proper action can be taken against offenders.

<u>Reminder!!</u> And also –Please do not feed the wild animals including feral cats, squirrels and ducks! They are creatures of the wild and should fend for themselves. After Association meetings at the Pools or gatherings at the Picnic area, any garbage should be removed and placed in a dumpster nearby.

#### <u>Garden Waste</u>

Plant debris should be piled or bagged and placed along the street, not at the dumpsters or parking lots, for pick up by the landscaping company on Tuesdays and Thursdays.

#### **Recycling and Trash**

Residents are urged to please help the environment by recycling whenever possible. Newspaper, flyers, flattened small cardboard boxes, catalogs, magazines, telephone books, paper grocery bags, clear, green and brown bottles and jars, aluminum and steel/tin food and beverage cans, all plastics #1 through #7 can all be places in the recycle bins.

#### Please, please, do not put plastic bags or garbage into the re-cycling bins!!!!

Before placing large cardboard boxes in the garbage bins, please **break them down** to ensure that the dumpsters are not filled before the garbage truck arrives. Small boxes should be collapsed and placed in the recycling containers.

For those units that have individual trash and recycling tote bins, please call **Collier County at 239-252-2380** for disposal of larger items such as TV's, mattresses, furniture, etc. For those using large dumpsters please contact **Roberto at 239-316-6452.** There is a charge for special pickup.

#### PLEASE DO NOT LEAVE ARTICLES BESIDE THE DUMPSTERS!!

For hazardous wastes such as paint, oil or solvents, they may be taken to the Waste Disposal site at 2640 Corporate Flight Drive with no fee. They are open Tuesday to Saturday from 8:30 a.m. to 4:30 p.m.

# **SWIMMING POOL RULES**

## **NO SMOKING**

ON THE POOL DECK OR IN THE CABANA, CAPACITY OF THIS POOL IS <u>23</u> PERSONS

Children 12 years of age and younger must be accompanied and supervised by a parent or other responsible person 16 years of age or older.

- Swimming is only permitted between dawn and dusk.
- All persons using any pool must be appropriately attired.
- All persons must shower before entering the pool.
- Pool safety equipment and cables should be kept in place and are not to be used except for their intended purpose.
- No inflatable devices over 2 feet in diameter are allowed. Noodles and swimming aids are allowed.
- No glass or animals in the fenced pool area (5 feet / 15.2 meters from unfenced pool.)
- Running, jumping, skating, bicycling or throwing any kind of item or any other activity that creates a danger or annoyance in the general pool area is prohibited.
- No food or beverage in the pool or on the wet deck. Commercially bottled water in plastic bottles is allowed on pool wet deck for pool patron hydration.
- Incontinent persons and infants not yet potty trained must wear pants specifically designed for use in the water, such as "little swimmers" while in any pool.
- Only radios with headphones may be used at the pool.

## **NO DIVING**

Do not swallow the pool water

Pool MAXIMUM depth: 6 FT
