### President's Corner

I hope that everyone had a terrific holiday season, and I am happy to welcome you to the 2026 season in our beautiful, active community. We have many new unit owners and seasonal renters this season who will have their first opportunity to enjoy the full slate of activities that we offer at Sapphire Lakes. I encourage you to use our community website: [www.sapphirlakesnaples.net](http://www.sapphirlakesnaples.net) to view our complete list of activities and other information about our community that will help you enjoy your time here. If you want to be included in the periodic email blast that myself and/or the Property Manager Suzanne Foster send out, please email me your email address to [rwfoster22@gmail.com](mailto:rwfoster22@gmail.com). If you're a seasonal renter, I can include you just for the three months that you're here.

One project that will be starting in early January will be an upgrade to your Xfinity equipment in your unit which will result in much faster upload and download speeds. (**See the article on page 1.**) In December we had some units undergo the upgrade to evaluate the process and plan for the whole community to experience the upgrade which will probably take 2-3 months to complete. Owners will be given information to call a special Xfinity phone number to schedule an appointment which will take 1 to 3 hours to complete. Xfinity will be mailing out some information to all owners and Bob and Suzanne will be sending out email blasts with information as needed.

The Activities Team has planned several special events, such as the January and April Picnics as well as the Chili Fiesta (February) that you can read about in other sections of this newsletter. The Bocce Committee is looking for a few more players to substitute in the Bocce League play which starts in mid-January. See the Bocce write up in this newsletter for more details.

One change that you will notice this year is that our landscape company, **Daley Lawn Care** has been bought out by a larger company, **Landscape Workshop**. However, they still are using the same landscape crew that they have been using with Daley since last January. And they have been doing an excellent job.

The Master Board will have a regular monthly Board meeting on Wednesday, January 21<sup>st</sup> at 10:00 am at Pool 3.

## **Sapphire Lakes Financial Update and Year-End Summary**

- **Season's Greetings and Overview**

First, I want to wish everyone a Happy New Year and hope everyone had a Merry Christmas. I am pleased to report that, financially, Sapphire Lakes is in good shape as we close out the year.

- **2025 Financial Performance**

It appears that we should end the year approximately \$13,000 under budget. Most of these savings are a result of additional income collected from Certificates of Deposit (CDs) and Money Market (MM) accounts, which together contributed \$10,000. In addition, we anticipate saving about \$3,000 in operating expenses.

- **Areas Over Budget**

Despite overall positive results, there were several areas where expenses exceeded the budget:

- Trash Removal: \$4,000 over budget
- Bushes Replacement: \$4,000 over budget
- Lake Maintenance: \$10,000 over budget
- Golf Cart Repairs: \$3,000 over budget
- Gate Repair: \$4,000 over budget

- **Areas Under Budget**

Fortunately, these overruns were offset by significant savings in other areas:

- Insurance Costs: \$15,700 under budget
- Irrigation Expense: \$8,000 under budget
- Building Maintenance: \$3,000 under budget

- **Contingency Fund Status**

All savings from this year's budget will be allocated to the contingency account, which currently stands just under \$100,000. With these additional savings, we will begin the new year with a balance of \$113,000 in the contingency fund. I would like to remind everyone that this money is held in a special Money Market account to be used exclusively for emergencies, such as hurricane recovery or unexpected expenses.

- **2026 Budget Outlook**

Looking ahead, the master operational budget for 2026 will increase by 3.90%. The contribution to reserve funds will rise from \$112,000 to \$130,000. This increase reflects higher projected costs of reserve items and the upcoming need to begin repaving the parking lots in 2027.

In terms of interest earnings, rates on CDs and Money Market accounts are expected to decline in 2026 due to the Federal Reserve reducing rates. We anticipate earning around 3.5% on CDs and 3% on Money Market reserves.

- **Reserve Account Activity**

In 2025, approximately \$73,500 was spent from the reserve account on the following projects:

1. Sealing and repairs to streets: \$65,850
2. Irrigation pumps: \$7,899

There are no projects planned from the reserves for 2026.

- **Closing Remarks**

Please note that all the numbers provided here are year-end estimates. We will share final figures in the next newsletter and at the annual meeting in March. I want to assure everyone that your board is working diligently to control expenses. Suzanne and Bob have been collaborating closely with me to manage costs, especially given the challenges our aging community faces and the impact of inflation.

We no longer have landline telephones at our four pools and instead we have replaced them with **911 Emergency Cell Phones**.

### **Rental of Cabanas**

Any resident wishing to use any of the cabanas for personal gatherings must apply fourteen (14) days in advance. Applications can be obtained from Suzanne Foster, Property Manager. This applies only to cabanas. Pools and pool decks are always open to all residents and may not be reserved or rented. A deposit of \$50 is required which will be refunded if the area is cleaned up properly. **Social distancing and hygiene plans will be reviewed with applicant before approval.** Further details are available in the application.

### **Attention Walkers, Bikers and Drivers**

**Walkers:** please make sure that you walk AGAINST the traffic when walking the streets at Sapphire Lakes and wear light colors and/or reflective clothing when walking in non-daylight hours. **Bikers:** please make sure to ride WITH the traffic and to have reflectors and/or lights on your bicycle. Helmets are recommended. We want everyone to be safe!!

**And vehicles,** please obey the Stop signs **including those at the driveways. Please be aware of those on the street walking or biking in these areas.** We have been fortunate that no one has caused an accident yet but the potential is there. Please do this for the safety of all!

### **Entrance Gates**

Unit owners may purchase additional gate access cards and vehicle bar codes at a **cost of \$25.00** by check or money order only and are available from our Property Manager, Suzanne Foster. Credit cards are now accepted but there is a \$1.06 service charge. **NO CASH.**

### **Pool Umbrellas**

All pools have umbrellas on the decks. If you are the last to leave the pool area, please be responsible and lower any umbrellas that are open. Thank you.

### **Defibrillators**

An Automated Electronic Defibrillator (AED) is installed at the cabana at the Recreation area restroom and all four pools.

Before using the AED machine, assure that **911** has been called. Turn on the AED and follow the audio prompts.

### **Central Car Washing Area**

There is an area located near the recreation area washroom facility for residents to wash cars. It is **mandatory** for boats to be washed only in this area. Boat rinsing should be limited to 15 minutes after it has been in saltwater.

### **Comcast Issues**

Any Comcast related issues should be addressed with Comcast by calling 1-800-XFINITY stating you are part of the Bulk Services Contract at Sapphire Lakes. It is also important to note that every Sapphire Lakes unit has a Comcast account. If you sell your unit, please be sure your name is removed from the account to ensure that you are not billed in the future. It would also be prudent to turn in your equipment to Comcast allowing the new owner to set up their own account with Comcast.

### **Your Pets**

Please report any violations of the pet rules that you witness or observe to our Property Manager, Suzanne Foster (353-2465) so that proper action can be taken against offenders.

**Reminder!!! And also –Please do not feed the wild animals including feral cats, squirrels and ducks!** They are creatures of the wild and should fend for themselves. After Association meetings at the Pools or gatherings at the Picnic area, any garbage should be removed and placed in a dumpster nearby.

### **Garden Waste**

Plant debris should be piled or bagged and placed along the street, not at the dumpsters or parking lots, for pick up by the landscaping company on Tuesdays and Thursdays.

### **Recycling and Trash**

**Residents are urged to please help the environment by recycling whenever possible. Newspaper, flyers, flattened small cardboard boxes, catalogs, magazines, telephone books, paper grocery bags, clear, green and brown bottles and jars, aluminum and steel/tin food and beverage cans, all plastics #1 through #7 can all be placed in the recycle bins.**

**Please, please, do not put plastic bags or garbage into the re-cycling bins!!!!**

Before placing large cardboard boxes in the garbage bins, please **break them down** to ensure that the dumpsters are not filled before the garbage truck arrives. Small boxes should be collapsed and placed in the recycling containers.

For those units that have individual trash and recycling tote bins, please call **Collier County at 239-252-2380** for disposal of larger items such as TV's, mattresses, furniture, etc. For those using large dumpsters please contact **Roberto at 239-316-6452**. There is a charge for special pickup.

### **PLEASE DO NOT LEAVE ARTICLES BESIDE THE DUMPSTERS!!**

For hazardous wastes such as paint, oil or solvents, they may be taken to the Waste Disposal site at 2640 Corporate Flight Drive with no fee. They are open Tuesday to Saturday from 8:30 a.m. to 4:30 p.m.

### **Collier Area Para Transit**

After approval, this service is provided to residents of Collier County needing assistance mainly traveling to medical appointments or nutrition sites. Information regarding this service can be obtained by calling Para Transit System at 239-252-7272.

## **SWIMMING POOL RULES**

### **NO SMOKING**

ON THE POOL DECK OR IN THE CABANA, CAPACITY OF THIS POOL IS  
**23** PERSONS

Children 12 years of age and younger must be accompanied and supervised by a parent or other responsible person 16 years of age or older.

- Swimming is only permitted between dawn and dusk.
- All persons using any pool must be appropriately attired.
- All persons must shower before entering the pool.
- Pool safety equipment and cables should be kept in place and are not to be used except for their intended purpose.
- No inflatable devices over 2 feet in diameter are allowed. Noodles and swimming aids are allowed.
- No glass or animals in the fenced pool area (5 feet / 15.2 meters from unfenced pool.)
- Running, jumping, skating, bicycling or throwing any kind of item or any other activity that creates a danger or annoyance in the general pool area is prohibited.
- No food or beverage in the pool or on the wet deck. Commercially bottled water in plastic bottles is allowed on pool wet deck for pool patron hydration.
- Incontinent persons and infants not yet potty trained must wear pants specifically designed for use in the water, such as “little swimmers” while in any pool.
- Only radios with headphones may be used at the pool.

### **NO DIVING**

Do not swallow the pool water

Pool MAXIMUM depth: **6 FT**
